- > Attach a copy of the overall Project Plot Plan (reduce if necessary), no larger than 11" x 16".
- If completion dates for construction are more than one year in the future, add cost increase factor based on your best estimate to reflect inflationary factors.
- If the common facilities are partially completed and only a portion of the construction will require a financial guaranty, complete the attached Subdivider Statement (RE 611C) and submit with RE 611A.
