The Commissioner ("Commissioner") of the California

Department of Real Estate ("Department") caused an investigation
to be made of the activities of IMPRESA DEVELOPMENT CORPORATION
("IMPRESA"), doing business as Loan Fixers, and PAUL CHIAVATTI
("CHIAVATTI"), and has determined that IMPRESA and CHIAVATTI have
engaged in or are engaging in acts or practices constituting
violations of the California Business and Professions Code
("Code") and/or Title 10, California Code of Regulations
("Regulations") including engaging in the business of, acting in
the capacity of, advertising, or assuming to act, as real estate
brokers in the State of California within the meaning of Section

10131(d) (soliciting borrowers or lenders or negotiating loans) and Section 10131.2 (claiming advance fees in connection with a loan) of the Code. Based on the findings of that investigation, as set forth below, the Commissioner hereby issues the following Findings of Fact and Desist and Refrain Order pursuant to Section 10086 of the Code.

FINDINGS OF FACT

- 1. At no time herein mentioned has IMPRESA or CHIAVATTI been licensed by the Department in any capacity.
- 2. At the time set forth below IMPRESA and CHIAVATTI engaged in the business of, acted in the capacity of, or advertised a loan modification service and advance fee brokerage using the name Loan Fixers offering to perform and performing loan modification services with respect to loans which were secured by liens on real property for compensation or in expectation of compensation and for fees often collected in advance as well as at the conclusion of the transaction.
- 3. On or about March 12, 2009, at 505 E. Grove Street, Orange, California 92865, IMPRESA and CHIAVATTI offered to enter into an agreement to negotiate a loan modification with respect to a loan secured by liens on real property in exchange for payment of an advance fee.

CONCLUSIONS OF LAW

4. Based on the information contained in Paragraph 3, above, IMPRESA and CHIAVATTI have performed and/or participated in loan modification activities which require a license under the provision of Code Sections 10131(d) and

10131.2 during a period of time when IMPRESA and CHIAVATTI were not licensed by the Department in any capacity.

DESIST AND REFRAIN ORDER

Based upon the FINDINGS OF FACT and CONCLUSIONS OF LAW stated herein, it is hereby ordered that IMPRESA DEVELOPMENT CORPORATION and PAUL CHIAVATTI immediately desist and refrain from performing any acts within the State of California for which a real estate broker license is required, and in particular, that they immediately desist and refrain from providing or participating in loan modification services unless and until they, individually, obtain an appropriate license issued by the Department.

Business and Professions Code Section 10139 provides that "Any person acting as a real estate broker or real estate salesperson without a license or who advertises using words indicating that he or she is a real estate broker without being so licensed shall be guilty of a public offense punishable by a fine not exceeding twenty thousand dollars (\$20,000), or by imprisonment in the county jail for a term not to exceed six months, or by both fine and imprisonment; or if a corporation, be punished by a fine not exceeding sixty thousand dollars (\$60,000)."
